

Gesventure increases its equity-capital and changes its juridical form into Anonymous Society

Capital increases to 80.000 Euros with the acquisition of 2 new partners

In the last March 27th Gesventure changed its juridical form from an quota to an anonymous shares company. This statutory change occurred in simultaneous with the increase of the social capital from 5.000 Euros to 80.000 Euros and with the acquisition of two new partners: Mr. Sérgio Póvoas, actual Operational Director, and Mrs. Carla Coelho, Gesventure jurist. With this, they now join the founder partners Mr. Francisco Banha (Gesventure's CEO) and Mr. Christophe Chausson (President of Chausson Finance).

The inclusion of these two technical experts in the Social Organs of the Company resulted from the recognition of their competency and hard-work performed since 1999 (when Gesventure was established), namely in the financial and juridical professional areas.
